2. The amount as indicated at para 1 above, will be drawn by the Drawing and Disbursing Officer (DDO), Grants-in-aid, Ministry of Youth Affairs and Sports on Grants-in-aid bill form and sent to each Youth Hostel. The payment will be drawn by the Wardens/Asstt. Wardens with the approval of Chairman, Hostel Management Committee. Excess payment made, if any, should be refunded to Government of India immediately.

3. The grant is subject to the following conditions:
- (i) The Accounts of the grant will be open to check by Comptroller & Auditor General of India at his discretion.
 - (ii) The amount shall not be utilized for purpose other than payment to the Warden/Assistant Warden of the Youth Hostel in the respective States as per details given in the Annexure.
 - (iii) A certificate will be furnished by the Warden, Youth Hostel to the effect that no such grant was/has been sanctioned for the same purpose by another Department of the Central Govt. or State Govt. during the period i.e. 2008-2009.

4. The expenditure is debitable to Major Head 2204, Demand No.105 - Ministry of Youth Affairs & Sports, Minor Head - 00.103 - Youth Welfare programme for Students, 01 - Youth Hostels, 01.00.31 - Grants-in-aid (Plan) 2008-2009.

5. This sanction issues in exercise of the powers delegated to this Ministry and in consultations with and concurrence of the Finance Unit of this Ministry vide their Dy. No. 2034/2009-FU, dated 09.03.2009.
