2. The grant of Rs.5,00,000/- (Rupees Five lakh only) shall be utilised for the purpose of facelifting of Youth Hostels mentioned above, keeping the ensuing Queen's baton Relay relating to the Commonwealth Games, 2010, in view, exclusively through following items of work on requirement basis:

- (i) External painting;
- (ii) Internal painting;
- (iii) Complete repair work of toilets;
- (iv) Patch-up repair work in the rooms and common areas; and
- (v) Complete cleaning of inside Youth Hostels building and outside premises.

3. The concerned Youth Hostel Warden/In charge shall have the work done through Central Public Works Department (CPWD)/any other Government Agency/Undertaking, as per the rules, on requirement basis to ensure that the work gets completed within a period of seventy five (75) days from receipt of the grant. This time limit shall be strictly adhered to by the concerned State Government Authority, as the facelifting work is related to forthcoming Queen's Baton Relay for Commonwealth Games, 2010.

4. A Central Monitoring team will visit the concerned Youth Hostels and will be in constant touch with the concerned Youth Hostel Warden/In charge to extend all possible assistance required.

5. The Youth Hostel Warden/In charge will furnish the Utilization Certificate/status report in respect of the grant. Any amount that might have been wrongly utilized for the purpose other than that for which that has been sanctioned shall be refunded without any delay, with penal interest as applicable. A separate ledger of account shall be maintained by each hostel in order to maintain the expenditure.

6. The pattern of grant/expenditure has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles, as approved by the Ministry of Finance.

7. The amount of Rs.5,00,000/- (Rupees Five lakh only) for each Youth Hostel mentioned in para 1 will be drawn by the Drawing and Disbursing Officer (Grant), Ministry of Youth Affairs & Sports through a Grants-in-aid bill and paid through ECS/Demand Draft in favour of the concerned Youth Hostel Warden/In charge mentioned above in the table.

8. The expenditure involved will be met out of the sanctioned budget Grant under Demand No. 105 - Ministry of Youth Affairs and Sports, Major Head "4202", Capital Outlay on Education, Arts & Culture, 101 - Youth Hostels, 01 - Payment to CPWD and Other agencies, 01.00.53 - Major Works (Plan) 2009-10.

9. This sanction issues in exercise of delegated powers and in consultation with the Finance Unit vide their Dy. No. 1686/2009-10/FU, dated 22.01.2010 and Dy. No. 1788/2009-10/FU, dated 16.02.2010.
