Monthly Report for the month of August, 2024

Name of the Ministry / Department: Department of Sports

1. Important policy decisions taken and major achievements during the month:

- a) India concluded its campaign at the Paris Olympics 2024 with a total of 6 medals, including 1 silver and 5 bronze. Notably, shooting discipline contributed 3 Bronze Medals through the stellar performances of Manu Bhaker, Sarabjot Singh and Swapnil Kusale. Neeraj Chopra won a Silver Medal in Javelin Throw, Aman Sehrawat claimed a Bronze Medal in Wrestling and the Indian Hockey Team successfully defended its Bronze Medal. All these athletes were invited in the Independence Day celebration at Red Fort as a Special Guest on 15th August 2024. Following this, they interacted with the Hon'ble Prime Minister.
- b) India made a history at the Paris Paralympics 2024, held from 28th August to 8th September 2024. The Indian contingent, the largest ever sent to the Paralympics, delivered a remarkable performance, winning a total of 29 medals: 7 gold, 9 silver, and 13 bronze. This impressive achievement earned India an 18th place in the medal tally, marking the country's best performance in Paralympic history.
- c) National Sports Day 2024, celebrated on August 29th, was a nationwide event with enthusiastic participation from all States and Union Territories. The event brought together around 7,000 organizations, including educational institutions, public sector undertakings (PSUs), non-governmental organizations (NGOs), and corporate entities.
- d) The Retired Sportsperson Empowerment Training (RESET) Programme was launched on National Sports Day, 29th August 2024, in New Delhi by the Hon'ble Minister of Youth Affairs and Sports. This initiative aims to empower retired athletes who have represented the country by providing them with the necessary knowledge and skills for career development, opening up new opportunities in the field of sports.
- e) On 5th August 2024, the Government of India signed a Memorandum of Understanding (MoU) with the Government of the Federation of Saint Christopher and Nevis, to enhance cooperation in sports. This MoU includes various initiatives such as exchange programs between the two countries and collaborations in sports research and development, aiming to foster mutual growth and knowledge-sharing in the field of sports.
- f) The National Anti-Doping Agency (NADA) organized 26 Anti-Doping Education Awareness programmes across the country in August.
- g) Building on India's success at the Paris Olympics, August 2024 brought several other significant sporting achievements for the country. At the U-17 World Wrestling Championship in Jordan, Ronak Dahiya secured a bronze medal in the Men's GR 110 kg category by defeating Turkey. The Indian Surfing team's qualification for the 2026 Asian Games was confirmed, with the team securing one quota each for men and women.
- h) To encourage the participation of women in sports, 09 ASMITA women's league competitions (4 Sports Disciplines: Cycling, Judo, Wushu and Yogasana) were organized in different parts of the Country.

5. Status of ongoing Swachhta Abhiyan (progress under Special Campaign):

Following activities were conducted for the special campaign of Swachhta Abhiyan:

- a) The Swachhta Campaign is being implemented by the National Anti-Doping Agency (NADA) and National Dope Testing Laboratory (NDTL) to integrate cleanliness as a part of the work culture.
- b) As a part of Swachhta Campaign, cleanliness drives are being organized at Sports Authority of India (SAI) Headquarters and it's Regional Centres with active participation of staff and athletes. Similar initiatives have also been taken at Lakshmibai National Institute of Physical Education (LNIPE) for a clean and hygienic campus.
- 6. Status of Rationalization of Autonomous Bodies:

Does not arise in the case of D/o Sports as all the five Autonomous Bodies- SAI, LNIPE, National Sports University (NSU), NADA and NDTL have been set up for specific purposes.
